WE HEREBY PROPOSE TO FURNISH LABOR, MATERIAL, EQUIPMENT, AND INSURANCE NECESSARY TO PREPARE AND PAINT THREE CLASSROOMS AT ALBANY MIDDLE SCHOOL IN ALBANY, CA.

### SCOPE OF WORK:

- 1) WALLS AND TRIM RECEIVING PAINT WILL BE CLEANED OFF;
- 2) TAPE, STAPLES, NAILS/SCREWS WILL BE REMOVED FROM THE WALLS;
- 3) PATCHING, FLOATING, AND PREPARATION WILL BE DONE TO THE AREAS ON THE WALLS WHERE NECESSARY;
- 4) PREVIOUSLY PAINTED DOOR FRAMES WILL BE LIGHTLY SANDED;
- 5) PRIMER WILL BE APPLIED TO PATCHES AND BARE AREAS. A HIGH ADHESIVE PRIMER WILL BE APPLIED TO THE ELECTRICAL RACEWAYS IN EACH ROOM AND ANY BARE METAL CONDUIT ALONG THE WALLS;
- 6) TWO FINISH COATS WILL BE APPLIED TO THE WALLS AND TRIM PREVIOUSLY PAINTED;
- 7) COLOR AND SHEEN TO MATCH EXISTING AT MIDDLE SCHOOL;
- 8) AREAS NOT RECEIVING PAINT WILL BE COVERED AND PROTECTED;
- 9) ITEMS/FURNITURE WILL BE MOVED AWAY FROM THE WALLS BY OWNER PRIOR TO STARTING.
