PURPOSE: The purpose of this item is for the Board of Trustees to approve the recommendations of the Board Policy Committee to adopt updated board policies.

BACKGROUND INFORMATION:

In June 2024, the Board approved a global adoption of almost all of AUSD's Board Policies to align with California Education Code(s). Since then, CSBA has issued quarterly updates from December 2023 - December 2024. The Board must continue to review recommended updates and approve them through the Consent Calendar

DETAILS:

The Board Policy Committee (BPC) reviews all policy updates and presents them to the Board for final approval and adoption. The BPC met on March 4, 2025 to continue to review mandated and quarterly updates on policies, administrative regulations, and exhibits. Many that were listed on the BPC Meeting agenda were tabled due to time constraints. These will be reviewed at the next BPC meeting on March 18, 2025.
