Revenue per Student (Average Daily Attendance) Comparison

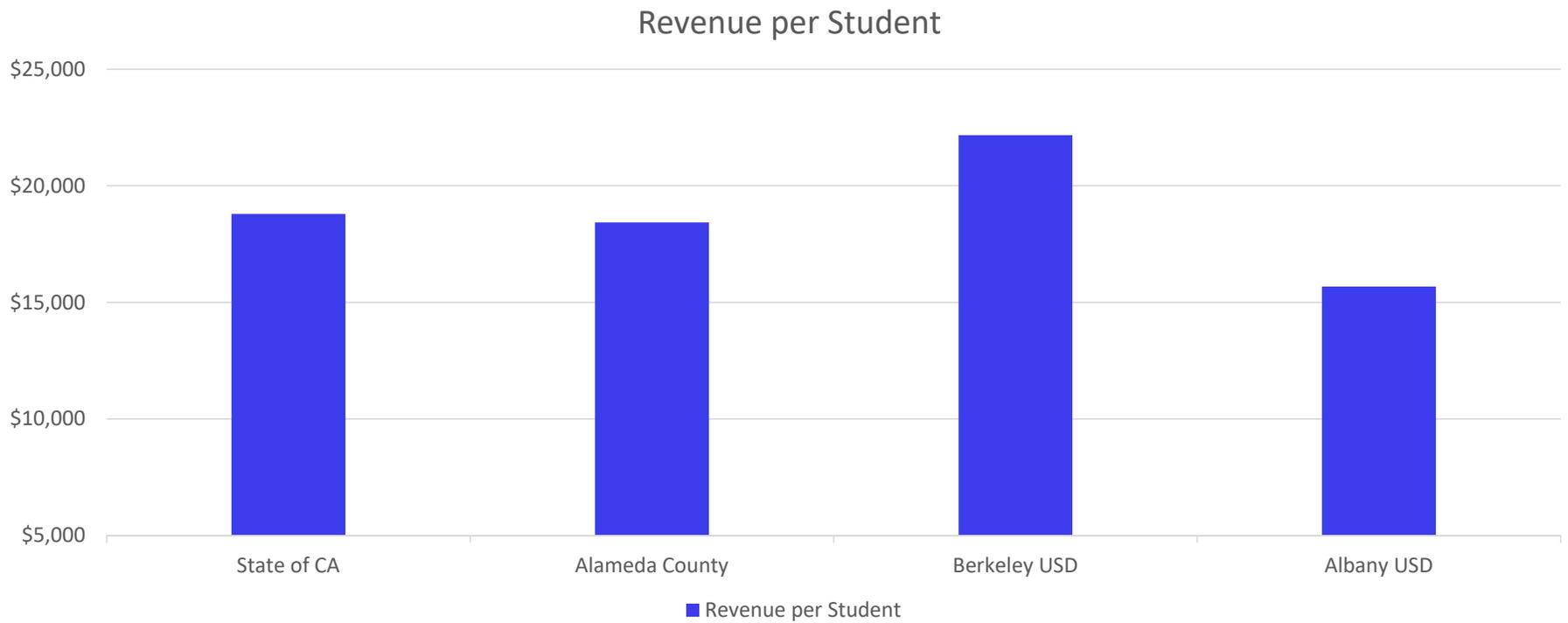

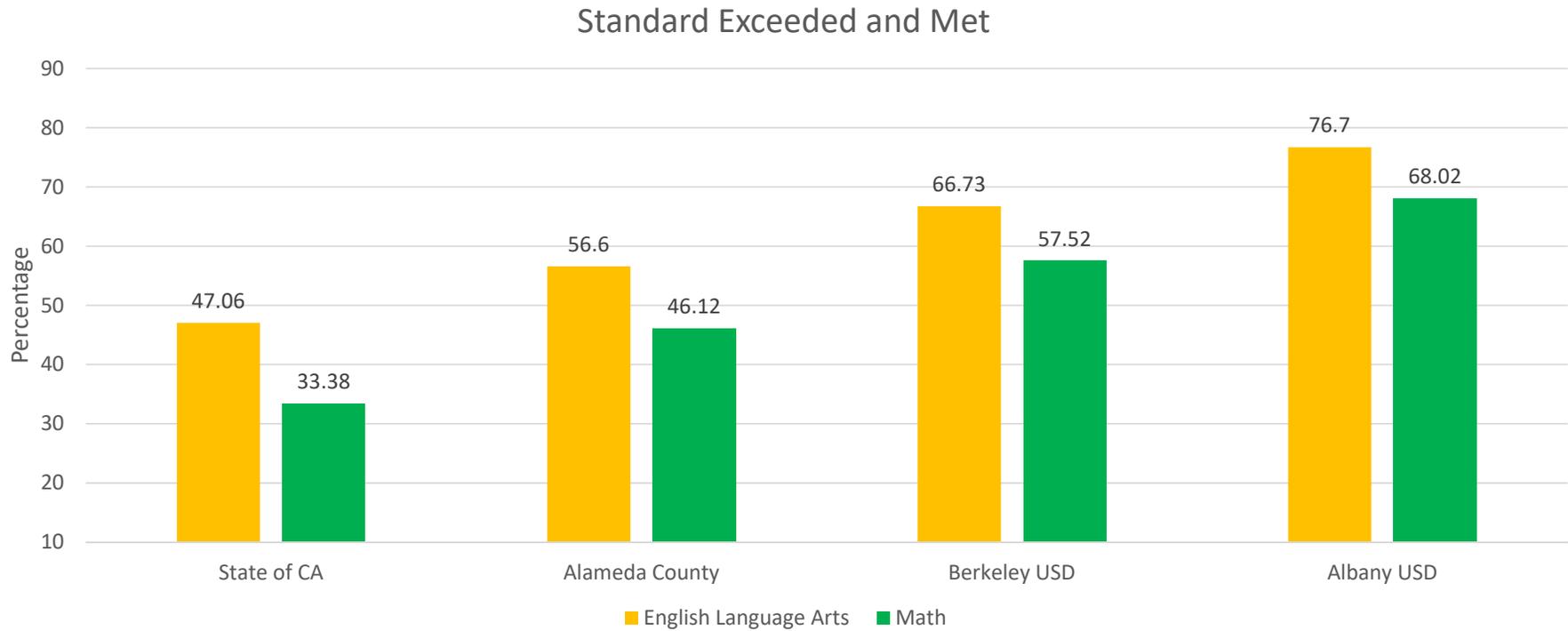

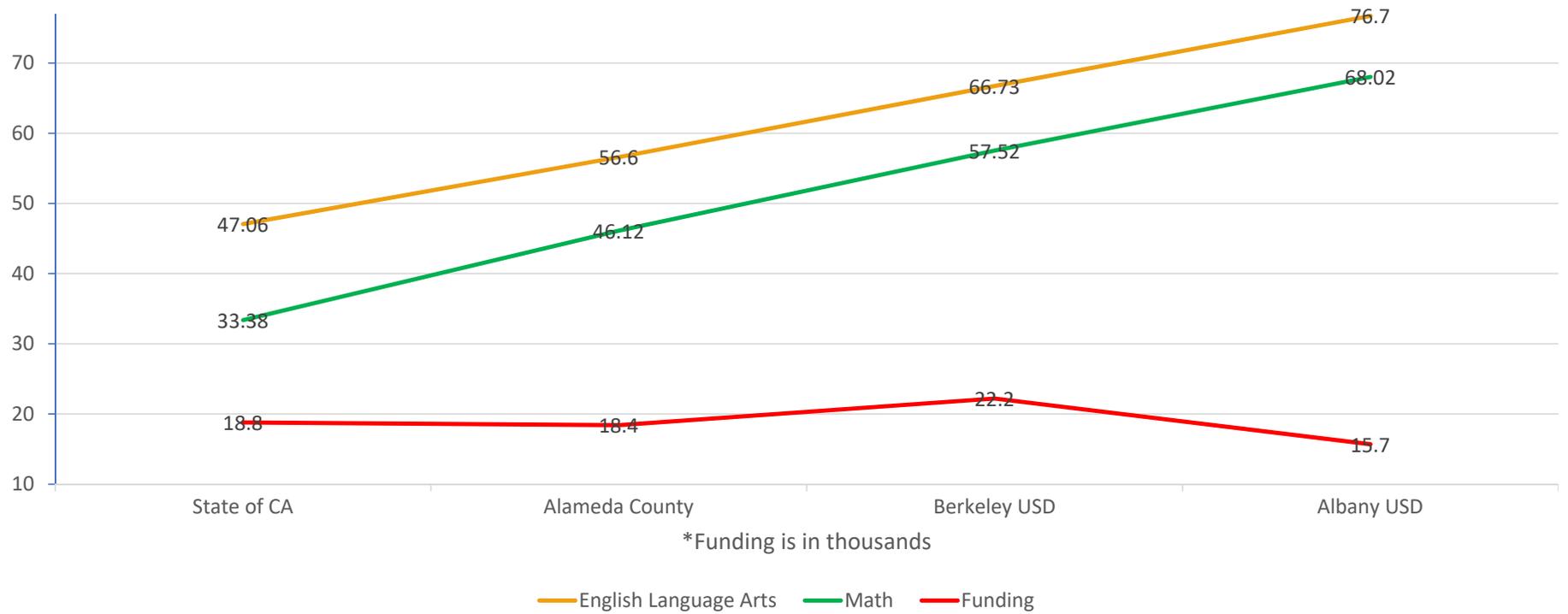
Funding per Student (Ed-Data.org)

Other Funds

The District administers 10 other funds other than General Fund.

- SELPA Administrative Unit
- Child Development
- Cafeteria Food Services
- Deferred Maintenance
- Special Reserve
- Building
- Capital Facilities
- County School Facilities
- Bond Interest & Redemption
- Capital Outlay Projects

Fund – a fiscal and accounting entity with a self-balancing set of accounts . This has specific purpose. If they are not solvent, the general fund will have to pay for exceeded expenditures.



Building Fund - \$95M

- This fund exists primarily to account separately for proceeds from the sale of bonds (*Education Code* Section 15146) and may not be used for any purposes other than those for which the bonds were issued.
- Albany voters approved Measure B and Measure E in June 2016 in amount of \$95 million.
- AUSD Board approved budget allocation for
 - Albany Middle School Annex : \$13.7 million
 - Albany High School Addition :\$9.8 million
 - Ocean View Elementary Re-Build: \$39.5 million
 - Marin Elementary Re-Build: \$32 million
- Citizens' Bond Oversight Committee oversees, monitors, and informs the public concerning the expenditures of general obligation bonds.

County School Facilities

- This fund was established to receive apportionments from the State School Facilities Fund. The fund is used primarily to account for new school facility construction, modernization projects and facility hardship grants.
- \$10,001,044 was received in January 2022 and the Board approved the allocation budget at December 14, 2021 Board Meeting.
