## History of Fire Prevention on "The Hill"

#### 2003 to 2010:

- Improved Hillside and Gateview access points
- "Hazardous Fire Area" signage posted at trail entrances
- Knox padlocks added to all access gates
- Fire roads re-established, and improved annually, at the top of Taft, and from , Top of the Hill to Pierce St by AFD personnel and Public Works.
- Our First Type-6 engine is placed in service
- Shelterbelt hired to perform annual vegetation management along fire roads and Creekside Park

#### 2010 to present:

- 2011 update to 1991 Albany Hill Plan
- 2012 Albany Hill Creekside Master Plan
- 2016 Measure R funds for Vegetation Mgmt.
- 2017 Albany Hill Vegetation Mgmt. Cord.
- 2020 Dry standpipe installed to supply fire road hydrant on top of hill
- 2021 Hydrant will be installed at Taft turnaround



Purpose: To provide guidelines for patrolling the Albany Hill area to ensure fire safety of hill residents and those

using the area for recreational purposes.

#### Procedure:


- A. Patrolling Albany Hill will begin when the California Department of Forestry (CDF) declares the fire season open and will end when CDF declares the season closed.
- B. Areas to be patrolled will include but are not limited to; the ends of Madison, Jackson, Hillside and Gateview Streets, the 535 Pierce St. fire access trail and the Albany Hill Park. The 535 Pierce and the Albany Park trails will either be walked or driven on one of the two days of each shifts tour.
- C. Under normal conditions, the hill will be patrolled once a day. When CDF declares a Red Flag Day or when conditions warrant, i.e., extremely hot/low humidity days, the Hill area will be patrolled at least twice a day.
- D. Patrolling will be conducted in 2192. 2140 or 2141 may be used to patrol the Hill, however 2192 is preferred due to its ability to travel along the park trails. The ambulance will not be utilized for this purpose.
  - When patrolling the Albany Hill Park area 2192 may enter at the end of Hillside, South end of 555
     Pierce or the top of Taft.
  - A Knox Lock will be used to secure the entrances at the end of Hillside and Taft.
  - c. Prior to leaving the paved road 2192 will be placed in four-wheel drive high.
  - d. A 10-mph speed limit shall be adhered to while driving on the park trails.
  - e. Due to the inherent danger with four-wheel driving, the driver will traverse hills by going straight up or down when possible. Any attempt to transverse a hill sideways should be avoided.
  - f. If the vehicle becomes trapped for any reason the driver shall not attempt to free the vehicle. The driver shall radio the station for assistance.
- E. Crews will report any activities deemed unsafe or conditions representing an extreme fire hazard to the on-duty officer. Illegal activities or evidence thereof shall be reported to APD. Examples of such activities include smoking, illegal burning, campfires, fireworks or vandalism to city property. When appropriate and practical, crews will attempt to educate or inform the public about the inherent dangers of activities related to fire hazards, in an urban/wildland interface zone.



Tree pruning for proper clearance between ground and branches

#### Key to Pruning Diagram

- The stem with foliage attached is below 8 feet so would be cut at the junction with the tree trunk.
- The branch even though it is under 8 foot in height, does not have any foliage directly attached below the 8 foot height, so would be left.
- The branch bends below 8 feet in height and so would be cut.
- 6 This stem is higher than 8 feet and so would be left.



## Vegetation Guidance Provided to Property Owners

- 1. Ensure all grasses are no greater than 4 inches in height that are within 30 feet of any walking trail, parking areas, seating areas, picnic tables, or other places people congregate on your property.
- 2. Ensure all grasses are no greater than 6 inches in height throughout your property unless otherwise stated in #1.
- 3. Limb up all trees 8 feet that are greater than 24 feet tall (see illustration below) on your property.
- 4. Limb up all trees 1/3 their height that are less than 24 feet tall on your property.
- Remove all "fuel jackpots" (leaf litter, logs, tree trunk rounds, dead branches, dead ivy/poison oak, shredded/draping bark, and dead vegetation) on your property.
- 6. Ensure bushes and shrubs have a separation of 3 times their height from all trees on your property.
- 7. Ensure the removal of any duff layers greater than 2 inches throughout your property.







Dear Property Owner:

This is a reminder of the City of Albany Code, Chapter 11, Section 2.3(f), property owners are required to remove noxious or dangerous vegetation and accumulated debris from their properties. These materials shall be removed to provide a clear 30-foot strip adjacent to surrounding improvements. Improvements include; structures, fences, hedges, shrubbery and trees. Grass and weeds must be cut short enough to prevent the spreading of fire (4 inch), and all cuttings and debris entirely removed from the property.

The work must be completed by June 25, 2021. In the event you do not have the work completed by June 25, 2021, a private contractor hired by the City will perform the required abatement. All costs of labor, materials, overhead and Fire Department fines will be assessed against your property until paid. It is not possible to estimate in advance the amount of these charges.

Your prompt attention to this abatement notice is appreciated. There will be no additional notices or reminders sent. If you have already completed the weed abatement of your property, the Albany Fire Prevention Bureau thanks you.
