TYPE OF ITEM: CONSENT

PURPOSE: The purpose of this item is for the Board of Trustees to approve the Independent Contractor Services Agreement with NV Construction for construction services at 1216 Solano Ave.

BACKGROUND INFORMATION: The Albany Unified School District's main offices are currently located in leased space in Berkeley CA. To relocate the main administrative office into a District-owned building located at 1216 Solano Avenue in Albany, the space needs to be modified to provide private offices and a conference room.

DETAILS: This project addresses the modifications to the existing space to accommodate the incoming staff. Private offices and a conference room will be built at the site.

FINANCIAL INFORMATION: The District's Program Manager (DCA) solicited bids for this work from 26 vendors. Two bids were received. NV Construction LLC provided the best price for the work at \$104,718 and is able to meet the District's desired schedule. This bid process and the resulting agreement are brought forward under the California Uniform Public Construction Cost Accounting Act (CUPCCAA) guidelines, which permit the District to follow an informal bid process and award a contract to the vendor providing the best value to the District for projects up to \$200,000. An allowance of \$20,000.00 is recommended.

• NV Construction LLC contract amount: \$104,718

Allowance for Unforeseen Conditions: \$20,000

• Total authorization: \$124,718

The cost will be covered by the bond measure.
